As part of a project funded by the BMUKN, a contractor is sought for the delivery **of 700 units of the acoustic logger "AudioMoth" including protective cases**. Delivery is to be made to **14 different addresses across Germany**, in accordance with a distribution list to be provided after contract award.

Specifications

Delivery Scope:

- **Product:** AudioMoth (minimum version 1.2.0 or technically equivalent)
- **Quantity:** 700 units
- **Accessories:** Optional accessories (e.g., cases, covers) should be listed separately
- **Condition:** Brand new, in original packaging
- **Compatibility:** Must be compatible with current firmware and configuration software
